Information Clauses on Data Protection

The party responsible for processing your personal data is Bilbao Exhibition Centre, S.A ('BEC'), with registered address at Ronda de Azkue 1, 48902 Ansio-Barakaldo. The purposes for processing your data are (i) managing your participation as an exhibitor at WORD MARITIME WEEK and the contractual relationship generated as a result of your participation in WORD MARITIME WEEK and (ii) keeping you informed of future events related to the sector that may be of interest to you. The personal data provided will be held by BEC until the termination of the legal relationship that resulted of your participation in WORD MARITIME WEEK, or, where appropriate, until you exercise your right of opposition to the purpose (ii). As of this time, BEC may store your data for a period of six years or for the limitation period of actions related to its responsibilities, when this period is in excess of the aforementioned. The legal grounds for the processing of your data is for purpose (i) the implementation of the legal relationship between BEC and you as an exhibitor, and, for purpose (ii) the legitimate interest of BEC, consisting of raising awareness of events held at BEC, related to the sector, that may be of interest to the recipient.
