INFORMATION CLAUSES (ACCESS FORMS)

- Bilbao Exhibition Centre, S.A. (with registered address in Ronda de Azkue 1, 48902 Barakaldo (SPAIN) 'BEC') and ADDIMAT, Spanish Association of Additive Manufacturing Technologies and 3D "ADDIMAT" (with registered address in Parque Científico y Tecnológico de Gipuzkoa, Paseo Mikeletegi, 59 20009 Donostia) are co-responsible for the processing of your personal data, as co-organizers of ADDIT3D. For these effects, they are committed to collaborate in good faith to guarantee compliance with the obligations established in the field of data protection and, more specifically, to fulfil the exercise of your rights in compliance with the conditions established in this policy.
- The purposes of the processing of your data by BEC and ADDIMAT are (i) managing your participation in the fair and the contractual relationship that is generated as a result of your participation as an exhibitor in ADDIT3D 2024, and (ii) keeping you informed of future events related to the sector that may be of interest to you.
- The personal data provided will be held by BEC and ADDIMAT until the termination of the legal relationship that resulted of your participation in 2024. where appropriate, until exercise your right of opposition ADDIT3D or, vou the purpose to (ii). As of this time, BEC and ADDIMAT may store your data, even blocked data, for a period of six years or for the limitation period of actions related to its responsibilities, when this period is in excess of the aforementioned.
