The processing of personal data will be carried out in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter, the "Regulation"). These data may be included in lists of companies requested by third parties who have a legitimate interest and wish to contact individuals or businesses within the Chamber's or the Council's area of jurisdiction, or who have or have had some form of relationship with these institutions in order to fulfil their functions under Law 14/2002 of 27 June, governing the Official Chambers of Commerce, Industry and Navigation of Catalonia and the General Council of the Chambers. These functions include, among others, the internationalisation, promotion and commercial support of Catalan companies. For the same purposes, these data may be disclosed to individuals, entities or companies, whether national or foreign. Any transfer of personal data to foreign entities or individuals shall be carried out in accordance with Articles 45 and 46 of the Regulation. Furthermore, where permitted by law, these data may be used to send promotional information to our customers and prospective customers regarding activities, products, services or initiatives of the Chambers of Commerce of Catalonia that are similar to those which they have contracted or about which they have requested information. In accordance with the Regulation, you may at any time exercise, free of charge, your rights of access, information, objection, rectification, erasure, the right to be forgotten, restriction of processing and data portability. Bilbao Exhibition Centre (registered office: Ronda de Azkue 1, 48902 Barakaldo, Spain) ("BEC"), which acts as data controller of your personal data in its capacity as organiser of Addit&D and the European Industrial Subcontracting Meeting 2027. To this end, BEC undertakes to cooperate in good faith to ensure compliance with data protection obligations and, in particular, to facilitate the exercise of your rights as set out in this policy.
The purposes for which BEC processes your personal data are: (i) the management of your participation in the exhibition and of the contractual relationship arising from your participation as an exhibitor at Addit&D; and (ii) keeping you informed about future events related to the sector that may be of interest to you. The personal data provided will be retained by BEC until the termination of the legal relationship arising from your participation or, where applicable, until you exercise your right to object to the processing described in purpose (ii). The legal basis for processing your data is: For purpose (i), the performance of the contractual and legal relationship between BEC and you as an exhibitor. For purpose (ii), BEC's legitimate interest in promoting: events held at BEC that are related to your sector and may be of interest to you. BEC will not disclose your data to third parties except where required by law. You have the right to access, rectify or erase your personal data, object to its processing (for example, to stop receiving commercial communications), request restriction of processing, or request data portability. To exercise these rights, you may submit a written request and proof of identity by email to protecciondedatos@bec.eu or by post to BEC's registered office, for the attention of Data Protection. If you no longer wish to receive commercial communications from BEC, you may also contact protecciondedatos@bec.eu to exercise your right to object. In addition, every commercial communication sent by BEC will clearly and simply provide you with the opportunity to exercise this right. You also have the right to lodge a complaint with the Spanish Data Protection Agency (Agencia Española de Protección de Datos), the supervisory authority responsible for data protection matters. If the exhibitor provides BEC with personal data relating to third parties during its relationship with BEC (for example, employees, contractors or external service providers), the exhibitor declares and warrants that it has duly informed such third parties of the contents of this notice and, where necessary, obtained their consent. In such circumstances, BEC shall not be required to take any additional action in this regard.
