DATA PROTECTION POLICY

The party responsible for processing your personal data is Bilbao Exhibition Centre, S.A ('BEC'), with registered address at Ronda de Azkue 1, 48902 Ansio-Barakaldo.

The purposes for processing your data are (i) managing your participation as an exhibitor at EGURTEK and the contractual relationship generated as a result of your participation in EGURTEK and (ii) keeping you informed of future events related to the sector that may be of interest to you.

The personal data provided will be held by BEC until the termination of the legal relationship that resulted of your participation in EGURTEK, or, where appropriate, until you exercise your right of opposition to the purpose (ii). As of this time, BEC may store your data for a period of six years or for the limitation period of actions related to its responsibilities, when this period is in excess of the aforementioned.

The legal grounds for the processing of your data is for purpose (i) the implementation of the legal relationship between BEC and you as an exhibitor, and, for purpose (ii) the legitimate interest of BEC, consisting of raising awareness of events held at BEC, related to the sector, that may be of interest to the recipient. BEC shall not share your information with third parties, unless legally required to do so.

You have the right to access, change or cancel your data, oppose their processing, or request the limitation of their processing or the portability of your data. Where appropriate, you may submit written requests to exercise the aforementioned rights, providing proof of identity, to [insert the applicable email address] or by letter addressed to BEC's registered address (FAO Data Protection).

Likewise, if you wish not to receive further commercial communications from BEC, you may write to the email [insert the applicable email address] to exercise your right of opposition. In addition, in each commercial communication that BEC sends you, the possibility of exercising this right of opposition will be offered in a clear and simple way.

You are also entitled to present a claim before the Spanish Data Protection Agency (Data protection Control Authority). Further information at www.aepd.es. If the exhibitor provides third party data during their relation with BEC (e.g. employee, contractor or supplier), the exhibitor declares and guarantees that these third parties have been duly informed of this notice and, where appropriate, their consent has been requested, without BEC having to carry out any additional action in this respect.
