## \*INFORMATION CLAUSES REFERING TO THE ACCESS FORMS \*

- ✓ The person responsible for the processing of your personal data is **Bilbao Exhibition Center, SA ("BEC")** as organizer of STEEL TECH, with registered office at Ronda de Azkue 1, 48902 Ansio-Barakaldo, together with the **Asociación Clúster de Siderurgia, ("SIDEREX ")** As co-organizer, with registered office at Parque Empresarial Ibarbarri C / Iturriondo 18, Edif. A-1 1<sup>o</sup>C. 48940 Leioa (Bizkaia)
