REGLAMENTO GENERAL DE PROTECCIÓN DE DATOS

The person responsible for the processing of your personal data is Bilbao Exhibition Center, SA ("BEC") as organizer of STEEL TECH, with registered office at Ronda de Azkue 1, 48902 Ansio-Barakaldo, together with the Asociación Clúster de Siderurgia, ("SIDEREX") As co-organizer, with registered office at Parque Empresarial Ibarrabarri C / Iturriondo 18, Edif. The purposes of the processing of your data by BEC and SIDEREX: (i) the management of your participation in the fair and the contractual relationship that, as a consequence of your participation as an exhibitor in STEEL TECH, is generated with you and (ii)) keep you informed of future events, related to the sector, that may be of interest to you.

The personal data provided will be kept by BEC and SIDEREX until the conclusion of the legal relationship derived from their participation in STEEL TECH or, where appropriate, until you exercise your right of opposition for the purpose (ii). From that moment on, BEC and SIDEREX will be able to keep your data, even if it is blocked, for a period of six years or for the limitation period of actions related to their respective responsibilities, when this period is longer than the one previously mentioned.

The cause of legitimacy for the processing of your data is, for the purpose (i), the execution of the legal relationship between BEC, SIDEREX and you, as exhibitor, and, for the purpose (ii), the legitimate interest of BEC and SIDEREX consisting of the dissemination of (a) events held at BEC, related to the sector, that could be of interest to the recipient.

BEC and SIDEREX will not transfer your data to third parties, except legal obligation.

You have the right to access, rectify or cancel your data, oppose treatment (for example, to stop receiving commercial information) or request the limitation of your treatment or portability of your data.

You may choose to send the written requests that, where appropriate, proceed, in order to exercise the above rights proving your identity, by email addressed to the address protecciondedatos@bec.eu or letter addressed to the registered office of BEC (A / A Data Protection).

Likewise, if you wish not to receive more commercial communications from BEC, you can contact electronic address protecciondedatos@bec.euto exercise your right to object. In addition, in each commercial communication that BEC sends you, you will be offered, in a clear and simple way, the possibility of exercising this right of opposition.
